THE EXPORT PROCESSING ZONES (DECLARATION) NOTICE, 2022

Cap. 373 WHEREAS section 3(1) of the Export Processing Zones Act, empowers the Minister, upon the advice of the Board and in consultation with the relevant Authorities and on recommendation of the Authority, by a Notice to be published in the *Gazette*, to-

- (a) establish or declare any area of land to be an Export Processing Zone; and
- (b) determine the location, extent and physical characteristics of boundaries of an Export Processing Zone;

AND WHEREAS, the Board of the Export Processing Zones Authority has advised the Minister to declare the areas specified in the Schedule to this Notice to be Export Processing Zone and the Minister after being advised, has consulted relevant Authorities and such Authorities having consented to such declaration;

Cap. 373 NOW WHEREFORE, in the exercise of the powers conferred upon me under section 3(1) of the Export Processing Zones Act, I, ASHATU K. KIJAJI the Minister for Investment, Industry and Trade do hereby declare the following areas as Export Processing Zone.

Citation 1. This Notice shall be cited as the Export Processing Zones (Declaration) Notice, 2022.
