THE SPECIAL ECONOMIC ZONES (DECLARATION) NOTICE, 2023

Cap. 420 WHEREAS section 8(1) of the Special Economic Zones Act gives mandate to the Director General of the Export Processing Zones Authority, hereinafter the “Director General”, , in consultation with the Minister responsible for lands, housing the local government authority and other relevant authorities to establish special economic zones and for that purpose identifying suitable land on which the established special economic zones will be situate and submit the proposal to that effect to the Authority for Approval;

AND WHEREAS, the Director General, in consultation with the Minister for Lands, Housing and Human Settlements, the Minister for Local Government Authority and other relevant authorities within the area in which the special economic zone is to be established, has identified suitable land on which the special economic zones to be established will be situate and thereafter submitted the proposal to the Authority for approval of the declaration of such an areas as special economic zonse ;

AND WHEREAS, the Authority has approved the proposal by the Director General to declare the lands identified in Pansiasi Ward Ilemela District in Mwanza Region, Nachingwea District in Lindi Region, Mkata Ward, Handeni District in Tanga Region, Pugu Road, Ilala District in Dar es Salaam Region, Mbalizi Area, Mbeya Urban in

Mbeya Region and Mwalugoya Area, Shinyanga Municipality in Shinyanga Region, to be suitable areas for the establishment of the special economic zones;

NOW WHEREFORE, in the exercise of the powers conferred upon me under section 8(2) of the Special Economic Zones Act, I, ASHATU K. KIJAJI, the Minister for Investments, Industry and Trade, do hereby declare the areas stated in this Notice as special economic zones as appearing herein below
