THE EXECUTIVE AGENCIES (TANZANIA FOREST SERVICES AGENCY)
(ESTABLISHMENT) (AMENDMENT) ORDER 2023

Citation

1. This Order may be cited as the Executive Agencies (Tanzania Forest Services Agency) (Establishment) (Amendment) Order, 2023 and shall be read as one with the Executive Agencies (Tanzania Forest Services Agency) (Establishment) Order, 2010 hereinafter referred to as the “principal Order”.

Deletion and

paragraph 2

2. The principal Order is amended by deleting paragraph 2 and substituting for it the following:

“Establishment
of Tanzania
Forest Services
Agency

“2. There is hereby established an Executive Agency to be known as Tanzania Forest Services Agency in its acronym “TFS” to manage national forest reserves, bee reserves, forest on general land and other functions as specified in the forest and beekeeping laws.”.

3. The principal Order is amended by adding immediately after paragraph 2 the following:

2A. The functions of Tanzania Forest Services Agency shall be to-
(a) provide forestry and

- beekeeping services;
- (b) manage national forest reserves, forest plantations, bee reserves, apiaries and forest in general land;
- (c) collect revenue on forest and beekeeping produce and services;
- (d) safeguard Tanzania Forest Services Agency property;
- (e) promote forest and bee products and services;
- (f) regulate forest produce trade; and
- (g) perform any other function legally assigned to the Agency.”.

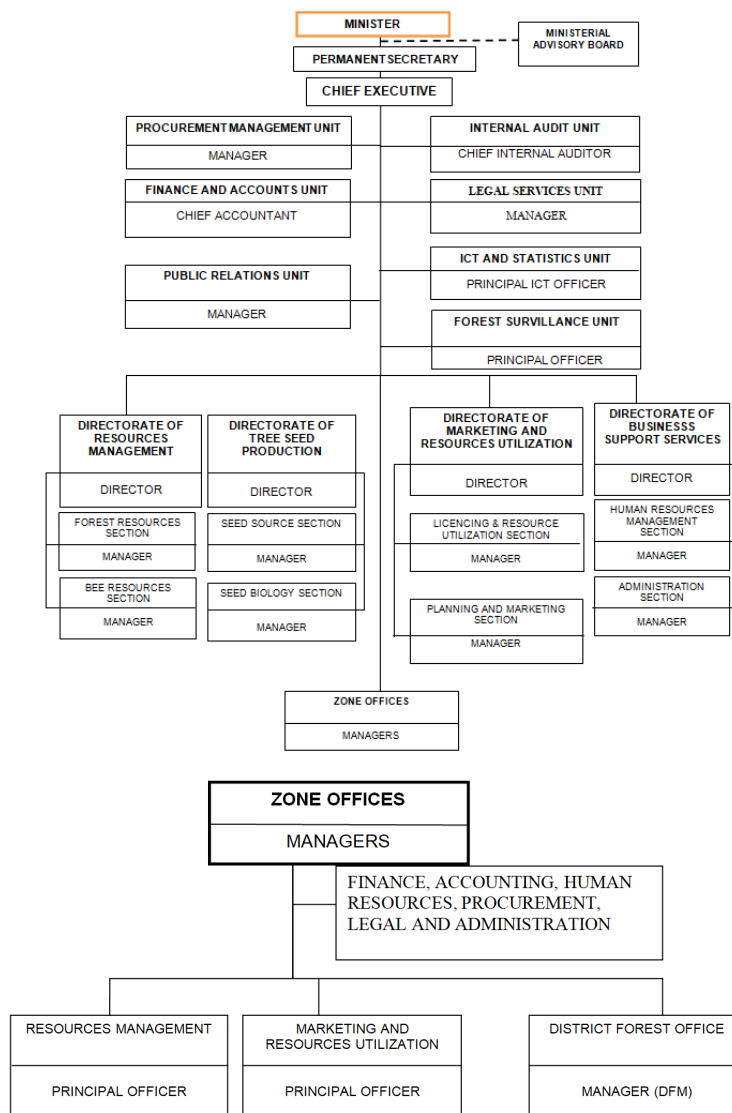
