THE VALUE ADDED TAX (EXEMPTION) (BUILDING SUSTAINABLE ANTI CORRUPTION ACTION IN TANZANIA)(SUPPLY OF OFFICE FURNITURE FOR THE PRESIDENT'S OFFICE- STATE HOUSE BY M/S MARIEDO LTD) (THE PRESIDENT'S OFFICE- STATE HOUSE) ORDER, 2020

Citation and
Commencement

1. This Order may be cited as The Value Added Tax (Exemption) (Building Sustainable Anti-Corruption Action in Tanzania) (Supply of Office Furniture for the President's Office- State House by M/s Mariedo Ltd) (The President's Office- State House) Order, 2020 and shall be deemed to have come into operation on the 26th day of January, 2020.

Exemption

2. Subject to the conditions specified in paragraph 3 of this Order, and any other conditions as may be specified by the Commissioner, the whole of the Value Added Tax payable on the goods or services specified in the Schedule to this Order imported or purchased prior to clearance through customs or locally by or on behalf of M/s Mariedo Ltd for President's Office- State House to be used solely in the project for Supply of Office Furniture for the President's Office- State House is hereby exempted.

Conditions

3. The exemption granted under this Order shall cease to have effect and the Value Added Tax shall become due and be payable as if this exemption have not been granted if the said items are used for other purposes, transferred, sold or disposed of in any way to another person not entitled to enjoy similar privileges as are conferred under this Order.

Expiry

4. This Order shall expire on the 25th day of May, 2020.
