This Order may be cited as the Value Added Tax (Exemption) (Kenya-Tanzania Power Interconnection Project) (KTPIP) Including (Iringa-Shinyanga Backbone Transmission Investment Project) (Tanzania Electric Supply Company Limited (Tanesco) (M/S Consortium Energoinvest-EMC Ltd) (Amendment) Order, 2020 and shall be read together with the Value Added Tax (Exemption) (Kenya-Tanzania Power Interconnection Project (KTPIP) (Iringa-Shinyanga Backbone Transmission Investment Project) (MS/ Consortium Energoinvest-Emc Ltd) Order, 2018 hereinafter referred to as the “principal Order”.
