## THE EXPORT PROCESSING ZONES (DECLARATION) NOTICE, 2021

WHEREAS section 3(1) of the Export Processing Zones Act, Cap. 373 empowers the Minister, upon the advice of the Board and in consultation with the relevant Authorities and on recommendation of the Authority, by a Notice to be published in the *Gazette*, to establish or declare any area of land to be an Export Processing Zone; and determine the location, extent and physical characteristics of boundaries of an Export Processing Zone;

AND WHEREAS, the Board of the Export Processing Zones Authority has advised the Minister to declare the areas specific in the Schedule this Notice to be Export Processing Zones and the Minister after being advised, has consulted the relevant Authorities and such Authorities having consented to such declaration;

NOW WHEREFORE, in the exercise of the powers conferred upon me under section 3(1) of the Export Processing Zones Act, I, KITILA A. MKUMBO, the Minister for Industry and Trade do hereby declare the following areas as Export Processing Zones.

Citation 1. This Notice shall be cited as the Export Processing Zones (Declaration) Notice, 2021.
