THE EXCISE (MANAGEMENT AND TARIFF) (REMISSION) (2 UNITS TOYOTA PRADO VEHICLE) (IMPROVING ACCOUNTABILITY THROUGH FIGHTING CORRUPTION AND INCREASED ACCESS TO JUSTICE (IMPACT)) (MINISTRY OF CONSTITUTIONAL AND LEGAL AFFAIRS) ORDER, 2020

Citation

1. This Order may be cited as the Excise (Management and Tariff) (Remission)(2 Unit Toyota Prado Vehicle)(Improving Accountability through Fighting Corruption and Increased Access to Justice (IMPACT)) (Ministry of Constitutional and Legal Affairs) Order, 2020 and shall be deemed to have come into operation on the 20th March, 2020.

Remission

2. Subject to the conditions specified in paragraph 3, and any other conditions as may be specified by the Commissioner General of Tanzania Revenue Authority, the whole of the excise duty payable on the Motor Vehicles in the Schedule to this Order imported or purchased prior to clearance through customs by or on behalf of Ministry of Constitutional and Legal Affairs to be used solely by Ministry of Constitution Affairs in the project for Improving Accountability through Fighting Corruption and Increased Access to Justice (IMPACT) is hereby exempted.

Conditions

3. The remission granted under this Order shall cease to have effect and the excise duty shall become due and be payable as if this Order had not been made if the said goods are used for other purposes or are transferred, sold or disposed of in any way to another person not entitled to enjoy similar privileges as are conferred under this Order.

Expiry

4. This Order shall expire on the 30 June, 2020.
