THE VALUE ADDED TAX (EXEMPTION) (BUILDING SUSTAINABLE ANTI CORRUPTION ACTION IN TANZANIA) (OFFICE EQUIPMENT FOR PREVENTION AND COMBATING OF CORRUPTION BUREAU) (PREVENTION AND COMBATING OF CORRUPTION BUREAU) ORDER, 2020

Citation and
Commencement

1. This Order may be cited as the Value Added Tax (Exemption) (Building Sustainable Anti Corruption Action in Tanzania) (Office Equipment for Prevention and Combating of Corruption Bureau) (Prevention and Combating of Corruption Bureau) Order, 2020 and shall be deemed to have come into operation on the 20th day of May, 2020.

Exemption

2.-(1) Subject to the conditions specified in paragraph 3 of this Order, and any other conditions as may be specified by the Commissioner General of Tanzania Revenue Authority, the whole of the Value Added Tax payable on the Office Equipment specified in the Schedule to this Order imported or purchased prior to clearance through customs or locally purchased by or on behalf of CI Group Limited for the Prevention and Combating of Corruption Bureau to be used solely by the Prevention and Combating of Corruption Bureau is hereby exempted.

(2) For avoidance of doubt, the said office equipment shall remain the property of the Government of Tanzania.

Conditions

3. The exemption granted under this Order shall cease to have effect and the Value Added Tax shall become due and be payable as if this exemption had not been made if the said office equipment are used for other purposes or sold or disposed of in any way to another person not entitled to enjoy similar privileges as are conferred under this Order.

Expiry

4. This Order shall expire on 20th day of November, 2020.
