Citation and
Commencement

1. This Order may be cited as the Value Added Tax (Exemption) (Supply of Stationery GFCU) (Ministry of Health, Community Development, Gender, Elderly and Children) (M/s Balikujile Traders) Order, 2020 and shall be deemed to have come into operation on the 09th day of July 2020.

Exemption

2. Subject to the conditions specified in paragraph 3 of this Order, and any other conditions as may be specified by the Commissioner, the whole of the Value Added Tax payable on the goods specified in the Schedule to this Order locally purchased on behalf of Ministry of Health, Community Development, Gender, Elderly and Children to be used solely in the project for Supply of Stationery GFCU is hereby exempt.

Conditions

3. The exemption granted under this Order shall cease to have effect and the Value Added Tax shall become due and be payable as if this exemption had not been made if the said goods and services are used for other purposes or sold or disposed of in any way to another person not entitled to enjoy similar privileges as are conferred under this Order.
