THE VALUE ADDED TAX (EXEMPTION) (BUILDING SUSTAINABLE ANTI-CORRUPTION ACTION IN TANZANIA) (SUPPLY AND INSTALLATION OF OFFICE FURNITURE AT GOVERNEMENT CITY-MTUMBA FOR MINISTRY OF FINANCE AND PLANNING) (PUBLIC PROCUREMENT REGULATORY AUTHORITY (PPRA)) (M/S CRAFT INNOVATION LTD) ORDER, 2020

Citation and commencement

1. This Order May be cited as The Value Added Tax (Exemption) (Building Sustainable Anti-Corruption Action in Tanzania) (Supply and Installation of Office Furniture at Government City-Mtumba for Ministry of Finance and Planning) (Public Procurement Regulatory Authority (PPRA)) (M/S Craft Innovation Ltd) Order, 2020 and shall be deemed to have come into operation on 9<sup>th</sup> July, 2020.

Exemption

2.-(1) Subject to the conditions specified in paragraph 3 and any other conditions as may be specified by the Commissioner General of the Tanzania Revenue Authority, the whole of the Value Added Tax payable on the goods or services specified in the Schedule to this Order locally purchased by or on behalf of Public Procurement Regulatory Authority (PPRA) by M/S Craft Innovation Ltd to be used solely by Ministry of Finance and Planning in the Project of Supply and Installation of Office Furniture at Government City-Mtumba for Ministry of Finance and Planning is hereby exempted.

(2)For avoidance of doubt, the goods imported or locally purchased, whether directly by the Government entity or through a contractor shall remain the property of the Government of the United Republic.

Conditions

3. The exemption granted under this Order shall cease to have effect and the Value Added Tax shall become due and be payable as if this exemption had not been granted where the said goods or services are used for other purposes or sold or disposed of in any way to another person not entitled to enjoy similar privileges conferred under this Order.

Expiry

4. This Order shall expire on 9<sup>th</sup> October,2020.
