THE VALUE ADDED TAX (EXEMPTION) (PROVISION OF SUPPORT AND MAINTAINANCE SERVICE FOR TANZANIA E-PROCUREMENT SYSTEM) (TANePS)) (PUBLIC PROCUREMENT REGULATORY AUTHORITY (PPRA)) (M/S EUROPEAN DYNAMICS) ORDER, 2020

Citation and Commencement

1. The Value Added Tax (Exemption) (Provision of Support and Maintenance Service for Tanzania E-Procurement System) (TANePS)) (Public Procurement Regulatory Authority (PPRA)) (M/S European Dynamics) Order, 2020, and shall be deemed to have come into operation on the 9<sup>th</sup> day of July, 2020.

Exemption

2.-(1) Subject to the conditions specified in paragraph 3 of this Order, and any other conditions as may be specified by the Commissioner General of Tanzania Revenue authority (TRA), the whole of the Value Added Tax payable on the goods or services specified in the Schedule to this Order, imported or purchased prior to clearance through customs or locally purchased by or on behalf of Public Procurement Regulatory Authority (PPRA)) to be used solely in the Project of Provision of Support and Maintenance Service for Tanzania E-Procurement System (TANePS) is hereby exempt.

(2) For avoidance of doubt, the goods imported or locally purchased, whether directly by the

Government entity or through a contractor shall remain the property of the Government of Tanzania.

Conditions

3. The exemption granted under this Order shall cease to have effect and the Value Added Tax shall become due and payable as if this exemption had not been granted where the said goods or services are used for other purposes or sold or disposed of in any way to another person not entitled to enjoy similar privileges as conferred under this Order.

Expiry

4. This Order shall expire on 8<sup>th</sup> day of October, 2020.
