THE VALUE ADDED TAX (EXEMPTION) (POVERTY REDUCTION PROJECT) (SUPPLY OF EIGHT MOTOR VEHICLES FOR TANZANIA SOCIAL ACTION FUND (TASAF)) (PRESIDENT'S OFFICE STATE HOUSE) (M/S GOVERNMENT PROCUREMENT SERVICE AGENCY (GPSA)) ORDER, 2020

Citation and commencement

1. This Order may be cited as the Value Added Tax (Exemption) (Poverty Reduction Project) (Supply of Eight Motor Vehicles for Tanzania Social Action Fund (TASAF) (President's Office State House) (M/S Government Procurement Service Agency (GPSA)) Order 2020 and shall be deemed to have come into operation on the 9<sup>th</sup> July, 2020.

Exemption

2.-(1) Subject to the conditions specified in paragraph 3 and any other conditions as may be specified by the Commissioner General of the Tanzania Revenue Authority, the whole of the Value Added Tax payable on the goods specified in the Schedule to this Order imported or purchased prior to clearance through customs by or on behalf of President's Office State House by M/S Government Procurement Service Agency (GPSA) to be used solely by Tanzania Social Action Fund (TASAF) in the Poverty Reduction Project is hereby exempted.

(2) For avoidance of doubt, the goods imported or locally purchased, whether directly by the Government entity or through a contractor shall remain the property of the Government of the United Republic.

- Conditions                    3. The exemption granted under this Order shall cease to have effect and the Value Added Tax shall become due and be payable as if this exemption had not been granted where the said goods are used for other purposes or sold or disposed of in any way to another person not entitled to enjoy similar privileges conferred under this Order.
- Expiry                         4. This Order shall expire on 9<sup>th</sup> October, 2020.
