THE VALUE ADDED TAX (EXEMPTION) (PROCUREMENT OF ACCESSORIES AND PRINTING MATERIALS FOR ESTABLISHMENT OF PCCB ONLINE TV) (PUBLIC PROCUREMENT REGULATORY AUTHORITY) (M/S JUMBO CAMERA HOUSE) ORDER, 2020

Citation and Commencement

1. This Order may be cited as the Value Added Tax (Exemption) (Procurement of Accessories and Printing Materials for Establishment of PCCB Online TV) (Public Procurement Regulatory Authority) (M/s Jumbo Camera House) Order, 2020 and shall be deemed to have come into operation on the 23rd day of July, 2020.

Exemption

2. Subject to the conditions specified in paragraph 3 of this Order, and any other conditions as may be specified by the Commissioner, the whole of the Value Added Tax payable on the goods specified in the Schedule to this Order imported or locally purchased prior to clearance through customs by or on behalf of M/s Jumbo Camera House to be used solely by Public Procurement Regulatory Authority in the project of Procurement of Accessories and Printing Materials for Establishment of PCCB Online TV is hereby exempt.

Conditions

3. The exemption granted under this Order shall cease to have effect and the Value Added Tax shall

become due and be payable as if this exemption had not been made if the said goods and services are used for other purposes or sold or disposed of in any way to another person not entitled to enjoy similar privileges as are conferred under this Order.

Expiry

4. This Order shall expire on 23th day of September, 2020.
