THE VALUE ADDED TAX (EXEMPTION) (INSTITUTIONAL SUPPORT PROJECT FOR GOOD GOVERNANCE (ISPGG III)) (PROCUREMENT OF ACCESSORIES AND PRINTING MATERIAL FOR ESTABLISHMENT OF PCCB ONLINE TV LOT NO. 2) (SUPPLY OF PRODUCTION EQUIPMENT) (PUBLIC PROCUREMENT REGULATORY AUTHORITY) ORDER, 2020

Citation and commencement

1. This Order may be cited as the Value Added Tax (Exemption) (Institutional Support Project for Good Governance (ISPGG III) (Procurement of Accessories and Printing Material for Establishment of PCCB Online TV Lot No. 2) (Supply of Production Equipment) (Public Procurement Regulatory Authority) Order, 2020 and shall be deemed to have come into operation on the 6th August, 2020.

Exemption

2.-(1) Subject to the conditions specified in paragraph 3 of this Order, and any other conditions as may be specified by the Commissioner General of the Tanzania Revenue Authority, the whole of the Value Added Tax payable on the goods and services specified in the Schedule to this Order imported or purchased prior to clearance through customs or locally purchased by or on behalf of Public Procurement Regulatory Authority by M/s G & L Bright Agency and Services Ltd to be used solely in Supply of Production Equipment is hereby exempted.

(2) For avoidance of doubt, the goods imported or locally purchased, whether directly by the Government entity or through a contractor shall remain the property of the Government of the United Republic.

Conditions

3. The exemption granted under this Order shall cease to have effect and the Value Added Tax shall become due and be payable as if this exemption had not been granted where the said goods or services are used for other purposes or sold or disposed of in any way to another person not entitled to enjoy similar privileges conferred under this Order.

Expiry

4. This Order shall expire on 6th October, 2020.
