1.-(1) This Order may be cited as the Value Added Tax (Exemption) (Village Electrification Initiative along the Backbone Transmission Investment Project (Supply and Installation of 220/33KV Substations Extension at Mtera Hydropower Plant-Lot I) (M/S Iran Power and Water Equipment Services Export Company) (Amendment) Order, 2020 and shall be read as one with the Value Added Tax (Exemption) (Village Electrification Initiative along the Backbone Transmission Investment Project (Supply and Installation of 220/33KV Substations Extension at Mtera Hydropower Plant-Lot I) (M/S Iran Power and Water Equipment Services Export Company) Order, 2019 hereinafter referred to as the principal Order.

(2) This Order shall be deemed to have come into operation on the 14th February, 2020.

2. The principal Order is amended generally by deleting the phrase “(M/S Iran Power and Water Equipment Services Export Company)” wherever it appears in the principal Order and substituting for it the phrase “Rural Electrification Agency (REA)”.
