Citation and
Commencement

1. This Order may be cited as the Value Added Tax (Exemption) (Upgrading Of Sawala - Mkonge - Iyegeya Road (30.3km) to Bitumen Standard Package I Ch: Km 0+000 To 18+000 in Mufindi District District) (Tanzania Rural and Urban Roads Agency (TARURA) (M/S Hematec Investment Limited Jv Webco Limited) Order, 2020 and shall be deemed to have come into operation on the 17th day of March 2020.

Exemption

2.-(1) Subject to the conditions specified in paragraph 3 of this Order, and any other conditions as may be specified by the Commissioner, the whole of the Value Added Tax payable on the goods or services specified in the schedule to this Order, imported or locally purchased prior to clearance through customs by or on behalf of M/S Hematec Investment Limited Jv Webco Limited to be used solely in the project of Upgrading of Sawala - Mkonge - Iyegeya Road (30.3km) to Bitumen Standard Package I Ch: Km 0+000 to 18+000 in Mufindi District District is here by exempt.

(2) For avoidance of doubt, the goods imported or locally purchased, whether directly by the Government entity or through a contractor shall

Conditions

3. The exemption granted under this Order shall cease to have effect and the Value Added Tax shall become due and be payable as if this exemption had not been made if the said goods or services are used for other purposes or sold or disposed of in any way to another person not entitled to enjoy similar privileges as are conferred under this Order.

Expiry

4. This Order shall expire on the 16th day of November, 2020.
