THE VALUE ADDED TAX (EXEMPTION) (NATIONAL AIDS CONTROL PROGRAMME (NACP)) (SUPPLY OF 5 TYRES FOR OFFICE MOTOR VEHICLE WITH REGISTRATION NUMBER DFPA 3934) (MINISTRY OF HEALTH, COMMUNITY DEVELOPMENT, GENDER, ELDERLY AND CHILDREN) ORDER, 2020

Citation and
Commencement

1. This Order may be cited as the Value Added Tax (Exemption) (National Aids Control Programme (NACP)) (Supply of 5 Tyres for Office Motor Vehicle with Registration Number DFPA 3934) (Ministry Of Health, Community Development, Gender, Elderly and Children) Order, 2020 and shall be deemed to have come into operation on the 29th day of September, 2020.

Exemption

2.-(1) Subject to the conditions specified in paragraph 3 of this Order, and any other conditions as may be specified by the Commissioner, the whole of the Value Added Tax payable on the goods and services specified in the Schedule to this Order locally purchased by Ministry of Health, Community Development, Gender, Elderly and Children from M/S Semvua Enterprises to be used solely in the project for Supply of 5 Tyres for Office Motor Vehicle with Registration Number DFPA 3934 is hereby exempt.

(2) For avoidance of doubt, the goods imported or locally purchased, whether directly by the Government entity or through a contractor shall remain the property of the Government of Tanzania.

Conditions

3. The exemption granted under this Order shall cease to have effect and the Value Added Tax

shall become due and be payable as if this exemption had not been made if the said goods and services are used for other purposes or sold or disposed of in any way to another person not entitled to enjoy similar privileges as are conferred under this Order.

Expiry
