THE VALUE ADDED TAX (EXEMPTION) (PERIODIC MAINTENANCE WORKS ALONG  
RUSUMO – LUSAHUNGA ROAD – LOT 2 CH 20+000+37+300) (TANZANIA NATIONAL  
ROADS AGENCY (TANROADS)) ORDER, 2020

Citation and  
commencement

1. The Value Added Tax (Exemption) (Periodic Maintenance Works along Rusumo – Lusahunga Road – Lot 2 CH: 20+000+37+300) (Tanzania National Roads Agency (TANROADS)) Order, 2020 and shall be deemed to have come in to operation on the 2<sup>nd</sup> day of November, 2020.

Exemption

2.-(1) Subject to the conditions specified in paragraph 3 of this Order and any other conditions as may be specified by the Commissioner, the whole of the Value Added Tax payable on the goods or services specified in the Schedule to this Order imported or purchased prior to clearance through customs or locally purchased by or on behalf of Tanzania National Roads Agency (TANROADS)) to be used solely by M/s Peter Mulima & Co. Ltd in the Periodic Maintenance Works along Rusumo – Lusahunga Road – Lot 2 CH: 20+000+37+300 is hereby exempted.

(2) For avoidance of doubt, the goods imported or locally purchased, whether directly by the Government entity or through a contractor shall remain the property of the Government of Tanzania.

Conditions

3. The exemption granted under this Order shall cease to have effect and the Value Added Tax shall
