THE EXCISE (MANAGEMENT AND TARRIF (REMISSION) (CONSTRUCTION, TESTING AND COMMISSIONING WATER SUPPLY SCHEMES AT KASULU, MPANDA, SIKONGE, URAMBO/KALIUA TOWNS, PACKAGE-V) (M/S MEGHA ENGINEERING & INFRASTRUCTURES LIMITED) ORDER, 2023

Citation and
commencement

1. This Order may be cited as the Excise (Management and Tarrif (Remission) (Construction, Testing and Commissioning Water Supply Schemes at Kasulu, Mpanda, Sikonge, Urambo and Kaliua Towns, Package-V) (M/S Megha Engineering & Infrastructures Limited) Order, 2023 and shall be deemed to have come in operation on the 28th day of December, 2022.

Exemption

2. Subject to the conditions specified in paragraph 3, and any other conditions as may be specified by the Commissioner General of Tanzania Revenue Authority, the whole of the excise duty payable on eleven motor vehicles specified in the Schedule to this Order, imported or purchased locally prior to clearance through customs by or on behalf of M/s Megha Engineering & Infrastructures Limited to be used solely in the implementation of the Construction, Testing and Commissioning Water Supply Schemes at Kasulu, Mpanda, Sikonge, Urambo and Kaliua Towns, Package-V, project is hereby remitted.

Conditions

3. The remission granted under this Order shall cease to have effect and the excise duty shall become due and payable as if this Order had not been made where the said motor vehicles are used for other purposes or are transferred, sold or disposed of in any way to another person not entitled to enjoy similar privileges conferred under this Order.

Expiry

4. This Order shall expire on the 28th August, 2023.
