THE EXPORT PROCESSING ZONES (DECLARATION) NOTICE, 2023

Cap. 373 WHEREAS, section 3(1) of the Export Processing Zones Act, empowers the Minister, upon the advice of the Board and in consultation with the relevant Authorities and on recommendation of the Authority, by a Notice to be published in the *Gazette*, to-

- (a) establish or declare any area of land to be an Export Processing Zone; and
- (b) determine the location, extent and physical characteristics of boundaries of an Export Processing Zone;

AND WHEREAS, the Board of the Export Processing Zones Authority has advised the Minister to declare certain areas of land to be Export Processing Zones and the Minister after being advised, consulted relevant authorities and such authorities having consented to the declaration of the areas of land set out in the Schedule to this Notice;

Cap. 373 NOW WHEREFORE, in the exercise of the powers conferred upon me under section 3(1) of the Export Processing Zones Act, I, KITILA ALEXANDER MKUMBO, the Minister of State, President's Office-Planning and Investment do hereby declare the areas specified in the schedule to this Notice as Export Processing Zones.
