ORDER, 2023

Citation and
commencement

1. This Order may be cited as the Excise (Management and Tariff) (Remission) (1 Motor Vehicle) (Supervision of Construction, Testing and Commissioning of Water Supply Scheme Project at Kayanga, Chato and Geita Towns (Ministry of Water)) Order, 2023 and shall be deemed to have come into operation on the 3rd day of November, 2023.

Remission

2. Subject to the conditions specified in paragraph 3, and any other conditions as may be specified by the Commissioner General of Tanzania Revenue Authority, the whole of the excise duty payable on the 1 motor vehicle specified in the Schedule imported or purchased locally prior to clearance through customs on behalf of the Ministry of Water to be used solely in supervision of the

Construction, Testing and Commissioning of Water Supply Scheme Project at Kayanga, Chato and Geita Towns is hereby remitted.

Conditions

3. The remission granted under this Order shall cease to have effect and the excise duty shall become due and be payable as if this remission had not been granted where the said motor vehicle is used for other purposes or transferred, sold or disposed of in any way to another person not entitled to enjoy similar privileges conferred under this Order.

Expiry

4. This Order shall expire on 2nd day of May, 2024
