| Citation | 1. This Order may be cited as the Criminal Procedure (Appointment of Photographic Experts) Order, 2023. |
| Appointment of Photographic Experts | 2. The persons whose names are specified in the Schedule to this Order are appointed to be photographic expert for purposes of giving report as evidence in any criminal case or related matters. |
| Validity | 3.-(1) The Appointment under this Order shall be valid for five years from the date of coming into operation of the Order.
(2). Notwithstanding the generality of this paragraph, a person appointed under this Order may serve for a period of not less than five years where such person's |

employment in the public service is determined or when such appointment is otherwise determined by the Director of Public Prosecutions.
