**THE MERCHANT SHIPPING (COUNTING AND REGISTRATION OF PERSONS ON BOARD PASSENGER SHIPS) (AMENDMENT) REGULATIONS, 2021**

Citation 1. These Regulations may be cited as the Merchant Shipping (Counting and Registration of Persons on Board Passenger Ships) (Amendment) Regulations, 2021 and shall be read as one with the Merchant Shipping (Counting and Registration of Persons on Board Passenger Ships) Regulations, hereinafter referred to as the “principal Regulations”.

2. The principal Regulations are amended generally by-

- (a) deleting the word “Authority” wherever it appears in the Regulations and substituting for it the word “Corporation”;
- (b) deleting the words “Registrar of Ships” wherever they appear in the Regulations and substituting for them the word “Registrar”.

3. The principal Regulations are amended in regulation 3, by-

- (a) designating the content of subregulation (1) as regulation 3;
- (b) deleting the definition of the terms “Authority” and “Registrar of Ships”;
- (c) deleting the words “the Surface and Marine Transport Regulatory Authority” appearing in the definition of the term “merchant shipping
