Citation 1. This order may be cited as the Occupational Health and Safety (Delegation of Powers) Order, 2024.

Delegation of Powers 2. The powers conferred to the Chief Inspector under section 88(2) of the Occupational Health and Safety Act are hereby delegated to the persons whose names are specified in the Schedule.
