2

1. These Regulations may be cited as the Tanzania Passports and Travel Documents (Amendment) Regulations, 2024 and shall be read as one with the Tanzania Passports and Travel Documents Regulations, 2004 hereinafter referred to as the “principal Regulations”.

2. The principal Regulations are amended generally by deleting the word “Director” wherever it appears in the Regulations and substituting for it the words “Commissioner General”.

3. The principal Regulations are amended in regulation 2, by-

- (a) deleting the definition of the term “Director”;
- (b) deleting the definition of the term “The East African Community” and substituting for it the following:

““The East African Community” means the Community established under Article 2 of the Treaty for the Establishment

of the East African Community of 1999;”; and

- (c) inserting in its appropriate alphabetical order the following new definition:

“Issuing Centres” means centres where passports and travel documents may be issued;”.

4. The principal Regulations are amended in regulation 3(1) by deleting the word “Dar es Salaam” and substituting for it the words “Mainland Tanzania.”

5. The principal Regulations are amended in regulation 4, by-

- (a) adding immediately after subregulation (1) the following:

“(2) Without prejudice to the provisions of subregulation (1), the application for Geneva Convention Travel Document shall be lodged through the office responsible for asylum and refugee services.”;

- (b) renumbering subregulations (2) and (3) as subregulations (3) and (4) respectively.

- (c) deleting subregulation (4) as renumbered and substituting for it the following:

“(4) Upon submission of the application for a passport, the applicant shall undergo the process of taking photograph and recording of fingerprints.”

6. The principal Regulations are amended in regulation 5, by-

- (a) adding a comma (,) and the words “Diplomatic Missions Abroad” immediately after the word “Zanzibar” appearing in subregulation (1);

- (b) adding the words “Diplomatic Missions Abroad,” between article “the” and the word “Regional” appearing in subregulation (2); and

- (c) adding immediately after subregulation (2) the

following:

“(3) An application for replacement of a Geneva Convention Travel Document shall be made through the office responsible for asylum and refugee services.”

7. The principal Regulations are amended in regulation 6, by-

- (a) deleting the opening phrase to regulation 6 and substituting for it the following:

“6. An applicant for a passport, where applicable, may be required to submit the following additional documents:”;
- (b) deleting subparagraph (i) and (iii) in paragraph (a) and renumbering subparagraphs (ii) to (vi) as subparagraphs (i) to (iv) respectively;
- (c) deleting subparagraph (ii) in paragraph (b) and renumbering subparagraph (iii) as subparagraph (ii);
- (d) deleting subparagraph (i) in paragraph (c) and renumbering subparagraphs (ii) to (vi) as subparagraphs (i) to (v) respectively; and
- (e) deleting subparagraph (i) in paragraph (f) and renumbering subparagraphs (ii) and (iii) as subparagraphs (i) and (ii) respectively.

8. The principal Regulations are amended in regulation 7-

- (a) by deleting subregulation (1) and substituting for it the following:

“(1) The application for an emergency travel document may be accompanied by-

  - (a) two passport size photographs;
  - (b) applicant’s birth certificate or an affidavit of birth;
  - (c) national identity card; and
  - (d) introduction letter from Ward Executive Officer or *Sheha*, where the applicant is

- from Zanzibar.”;
- (b) in subregulation (2), by-
- (i) deleting the word “and” appearing at the end of paragraph (a);
  - (ii) deleting a full-stop appearing at the end of paragraph (b) and substituting for it a semi-colon and the word “and”; and
  - (iii) adding immediately after paragraph (b) the following:  
“(c) written statement of the applicant where necessary.”; and
- (c) adding immediately after subregulation (3) the following:
- “(4) The Commissioner General may waive any requirement stipulated under this regulation as circumstances may deem necessary.”

9. The principal Regulations are amended in regulation 8-

- (a) in subregulation (1), by-
- (i) deleting paragraph (b) and substituting for it the following:  
“(b) passport size photographs where necessary.”;
  - (ii) adding immediately after paragraph (b) the following:  
“(c) any other document as may be required.”
- (b) in subregulation (2), by-
- (i) deleting paragraph (b) and substituting for it the following:  
“(b) passport size photographs where necessary.”;
  - (ii) adding immediately after paragraph (b) the following:  
“(c) any other document as may be required.”

10. The principal Regulations are amended in regulation 10 by adding immediately after subregulation (3) the following:

“(4) Fee paid relating to application for passport and travel documents shall be non-refundable.

(5) The Minister may, upon recommendation of the Commissioner General on reasonable grounds, exempt an applicant for a passport or travel document from repayment of fee for the same application.

(6) Where the Minister refuses to grant the exemption, the applicant shall pay the prescribed fee.”.

11. The principal Regulations are amended in regulation 11 by deleting the words “section 8 of” appearing in subregulation (1).

- (b) deleting the words “one hundred thousand shillings” appearing in subregulation (9) and substituting for them the words “two hundred thousand shillings and not exceeding one million shillings”.


