NOTICE 2024

Citation

1. This Notice may be cited as the National Prosecutions Service (Appointment of Public Prosecutors) Notice, 2024.

Appointment of

2. The persons whose names are specified in the Schedule are hereby appointed to be public prosecutors for purposes of prosecuting criminal cases on behalf of the Director of Public Prosecutions.

Tenure of
appointment

3.-(1) A public prosecutor appointed under paragraph 2 shall serve for a period of five years from the date of coming into operation of this Notice.

(2) Notwithstanding subparagraph (1), a public prosecutor appointed under this Notice may serve for a period less than five years, if his employment in the public service is terminated or when his appointment is otherwise revoked by the Director of Public Prosecutions.
