THE TANZANIA SHIPPING AGENCIES (RATIFIED INTERNATIONAL CONVENTIONS

Citation

1. This Notice may be cited as the Tanzania Shipping Agencies (Ratified International Conventions and Regional Instruments) Notice, 2025.

Interpretation

2. In this Notice, unless the context otherwise requires-
“ratified international convention and regional instrument” means a convention, treaty, agreement, protocol or other legally binding international or regional instrument that has been ratified by the United Republic of Tanzania under Article 63 (3) (d) and (e) of the Constitution of the United Republic of Tanzania, 1997.

- (l) the International Convention on Maritime Search and Rescue (SAR), 1979;

- (n) the International Convention for Prevention of Pollution from Ships (MARPOL), 1973;
- (o) the Convention for the Suppression of Unlawful Acts Against the Safety of Maritime Navigation (SUA Convention); 1988;
- (p) the International Convention on Oil Pollution Preparedness, Response and Cooperation (OPRC), 1990;
- (q) the International Maritime Labour Convention (MLC), 2006;

- (r) the Convention on the Facilitation of International Maritime Traffic, (FAL Convention), 1965

- (t) the International Convention for the Unification of Certain Rules of Law Relating to Bills of Lading and Protocol of Signature (Hague Rules), 1924; and
- (u) the United Nations Convention on the Carriage of Goods by Sea (Hamburg Rules), 1978.
