1. These Rules may be cited as the Magistrates' Courts (Approved Forms for the Primary Courts) (Amendments) Rules, 2025 and shall be read as one with the Magistrates' Courts (Approved Forms for the Primary Courts) Rules, 1971 hereinafter referred to as the "principal Rules".

2. The principal Rules are amended in the Schedule by-

- (a) deleting the words "/Ndoa" appearing in FOMU MADAI-2 of "SEHEMU YA KWANZA II";
- (b) redesignating the title "FOMU ZA MIRATHI MAHAKAMA ZA MWANZO" in SEHEMU YA KWANZA III" as "FOMU ZA NDOA MAHAKAMA ZA MWANZO";
- (c) deleting "FOMU MIRATHI-1, FOMU MIRATHI-2, FOMU MIRATHI-3, FOMU MIRATHI-4, FOMU MIRATHI- 5, FOMU MIRATHI-6, FOMU MIRATHI-7 and FOMU MIRATHI-8;" from SEHEMU YA KWANZA III; and
- (d) inserting in SEHEMU YA KWANZA III the following:
