THE PRIMARY COURTS(ADMINISTRATION OF ESTATES)
(AMENDMENT) RULES, 2025

- Citation 1. These Rules may be cited as the Primary Courts (Administration of Estates) (Amendment) Rules, 2025 and shall be read as one with the Primary Courts (Administration of Estates) Rules, 1971 hereinafter referred to as the "principal Rules".

- Amendment of rule 2 2. The principal Rules are amended in rule 2 by inserting in the appropriate alphabetical order the following definition:
"“special *mirathi* account” means a bank account opened by an administrator for the purpose of collecting monies forming part of the estate of the deceased;”.
- Deletion and substitution of rule 3 3. The principal Rules are amended by deleting rule 3 and substituting for it the following:
“Application 3.-(1) An application for the appointment of administrator under paragraph 2(a) or 2(b) of the Fifth Schedule to the Act, shall be made in FOMU MIRATHI-1.
(2) Where an application is for the first time made after expiration of twelve months from the death of the deceased, the application

shall contain a statement explaining the delay.

(3) Where the explanation in the application is unsatisfactory, the court may require such further proof of the alleged cause of delay as it may think fit.

(4) An application under this rule shall be accompanied by a death certificate issued by a competent authority.

(5) Where for any reason beyond the control of the petitioner, a death certificate is not available, the petitioner shall file a burial permit issued by a competent authority instead of death certificate, an affidavit from a person who saw the remains of the deceased being interred or cremated or an affidavit from a medical practitioner, duly registered, who pronounced the death of the deceased or any other affidavit which, in the opinion of the court, is sufficient to prove the death of the deceased.”.

Amendment
of rule 4

4. The principal Rules are amended in rule 4 by deleting subrule (3) and substituting for it the following:

“(3) If the applicant delivers to the officer of the court a document which he claims to be the Will of the deceased person, or to be the terms of such Will, the officer shall forthwith make a copy thereof, place it in safe custody, and require the applicant to produce the original on the hearing date.”

Amendment
of rule 5

5. The principal Rules are amended in rule 5 by-
- (a) deleting the words “the appropriate Form” appearing in subrule (2) and substituting for them the words “FOMU MIRATHI-2;
 - (b) adding immediately after subrule (4) the following:
 - “(5) No grant shall be made until the expiration of fourteen days from the date of the last publication.
 - (6) Where an objection has been made by any interested person, the court shall record such objection, call upon the applicant to substantiate his application, hear the objector and determine whether or not to grant the application.”.

of rule 7

6. The principal Rules are amended in rule 7-
- (a) in subrule (1), by deleting the words “Form III and shall state the property to be administered” and substituting for them the words “FOMU MIRATHI - 4”;
 - (b) in subrule (2), by deleting the words “Form IV” and substituting for them the words “FOMU MIRATHI-4”;
 - (c) in subrule (3), by inserting the words “in FOMU MIRATHI-3 set out in the Schedule” between the words “, estate” and “and”.

of rule 9

7. The principal Rules are amended in rule 9-
- (a) in subrule (1), by inserting the words “in FOMU MIRATHI-7 set out in the Schedule” between the words “administration” and “to”;
 - (b) by adding immediately after subrule (1) the following:
 - “(2) The revocation or annulment of a grant shall be made in FOMU MIRATHI-8 set out in the Schedule.”;
 - (c) by renumbering subrule (2) as subrule (3).

Deletion and substitution of rule 10

8. The principal Rules are amended by deleting rule 10 and substituting for it the following:

“Inventory and accounts of estate

10.-(1) Within three months of the grant of administration or within such further period of time as the court may allow, the administrator shall submit to the court-

(a) a true and complete statement, in FOMU MIRATHI-5 set out in the Schedule, of all the assets and liabilities of the deceased person’s estate; and

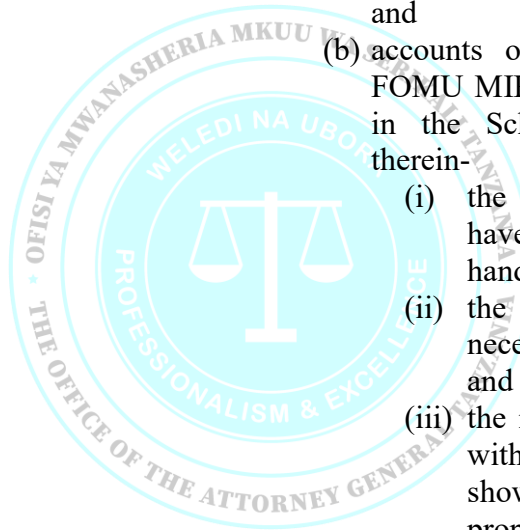
(b) accounts of the estate in FOMU MIRATHI-6 set out in the Schedule showing therein-

(i) the assets which have come to his hands;

(ii) the expenses necessarily incurred; and

(iii) the residue, together with a statement showing in what proportion and to whom the residue is proposed to be paid or distributed.

(2) Unless the court orders otherwise, upon exhibition of an inventory and accounts, the administrator shall cause heirs and beneficiaries of the estate to appear in court for confirmation of inventory and accounts on the date fixed for such purpose.

(3) Any beneficiary under a Will, a person entitled to a share under intestacy or unsatisfied creditor shall be entitled to inspect the inventory and accounts of estate.”.

Addition of
rules 10A
and 10B

9. The principal Rules are amended by adding immediately after rule 10 the following:

“Objection,
confirmation
and closure

10A.-(1) Where any person with interest in the estate of the deceased is dissatisfied with the inventory or accounts, he may raise an objection to the court orally or in writing before confirmation of such inventory or accounts.

(2) Where an objection is made, the court shall hear the parties on the objection, determine it and give directions to the administrator or confirm the inventory or accounts of estate.

(3) Upon confirmation of accounts, the court shall direct the administrator to distribute the estate according to the accounts and perform all acts necessary thereto and report on completion thereof within the specified time.

(4) Where the report is made under subrule (3), the administration of estate shall be marked closed:

Provided that, no administration cause shall be marked closed unless the court is satisfied that all properties have been transferred to the rightful heirs or beneficiaries, and there is no any known pending litigation against the estate.

10B.-(1) Upon appointment, the administrator shall open a special *mirathi* account and avail its details to the court.

(2) Subject to any other written laws, all monies forming part of the estate of the deceased person shall be deposited into a special *mirathi* account.

(3) Where circumstance requires, the court shall, through FOMU MIRATHI-9 set out in the Schedule, facilitate the administrator to transfer monies into the special *mirathi* account.

(4) Upon transfer of the deceased's monies into special *mirathi* account, the transferor shall submit to court confirmation of such transfer which shall be accompanied by a statement of such account from the date of the death of the deceased.

(5) Monies shall not be paid from the special *mirathi* account except by an order of the court.

(6) The administrator shall provide the details of bank accounts of the heirs and beneficiaries in FOMU MIRATHI-6.

(7) The special *mirathi* account shall be closed following the confirmation of accounts and the transfer of funds to the respective heirs or beneficiaries, in accordance with the account of estate of the deceased.”.
