1. These Regulations may be cited as the Immigration (Visa) (Amendment) Regulations, 2025 and shall be read as one with the Immigration (Visa) Regulations, 2016 hereinafter referred to as the “principal Regulations”

2. The principal Regulations are amended by deleting the phrase “holder of service or official passport” appearing immediately after the word “staff,” and substituting for them the words “staff of recognized International Organizations, holder of Diplomatic, Service or Official passport”.

3. The principal Regulations are amended in Part D of the Second Schedule that relates to Diplomatic visa by adding immediately after item D6 the following:

D6 page of an
