THE UNIVERSITY OF DAR ES SALAAM (ESTABLISHMENT OF CAMPUS COLLEGES, SCHOOLS AND INSTITUTES) (AMENDMENT) ORDER, 2020

WHEREAS section 45(2)(g) of the Universities Act, vests unto the Council of the University powers to establish or disestablish schools, faculties, institutes and departments or similar organs of equivalent designations;

WHEREAS, pursuant to the signing of the Memorandum of Understanding between the Ministry of Minerals, Ministry of Education Science and Technology and the University of Dar es Salaam executed on 20th February 2020 through which the Mineral Resource Institute was incorporated and placed under the University of Dar es Salaam in terms of the provisions of the under the University of Dar es Salaam Charter of 2007;

AND WHEREAS the Council of the University of Dar es Salaam, exercising its functions under Article 17 of the University of Dar es Salaam Charter, 2007 read together with rule 12(2)(i) and 37(2) of the University of Dar es Salaam Rules, 2007, and acting on the recommendation of the Senate resolved to establish the University of Dar es Salaam Mineral Resources Institute;

NOW THEREFORE, I, DAMIAN ZEFRIN LUBUVA, Chairman of the Council of the University of Dar es Salaam do hereby make the following Order:

This Order may be cited as the University of Dar es Salaam (Establishment of Campus Colleges, Schools and Institutes)(Amendment) Order, 2020 and shall be read as one with the University of Dar es Salaam (Establishment of Campus Colleges, Schools and Institutes) Order, 2010, hereinafter referred to as the “principal Order”.
