Citation 1. These Rules may be cited as the Petroleum (Natural Gas) (Licensing Fees) Rules, 2020.

Fees 2. The fees prescribed in the Schedule to these Rules shall apply in respect of application for construction approval and operational licence in natural gas regulated activities.
