THE LOCAL GOVERNMENT (URBAN AUTHORITIES) (VARIATION OF
BOUNDARIES OF LINDI MUNICIPAL COUNCIL) ORDER, 2020

WHEREAS, in pursuance of the provisions of section 11 of the Local Government (Urban Authorities Act, Cap. 288, the Minister responsible for local government did issue a notice of the intention to vary boundaries of Lindi Municipal Council as specified in the Notice published in the *Gazette* as Government Notice No. 76A of 2020.

AND WHEREAS, no objection or representation was received by the Minister such as would justify any delay in varying boundaries of the Lindi Municipal Council until the expiry of the Notice;

NOW, THEREFORE, in exercise of the powers conferred upon the Minister responsible for local government by the provisions of section 11 of the Local Government (Urban Authorities) Act, Cap. 288, the following Order is issued:

Citation	1. This Order may be cited as the Local Government (Urban Authorities) (Variation of Boundaries of Lindi Municipal Council) Order, 2020.

Variation of boundaries	2. The boundaries of an area under the jurisdiction of Lindi Municipal Council are hereby varied as set out in the Schedule to this Order.

SCHEDULE

(Made under paragraph 2)

BOUNDARIES OF LINDI MUNICIPAL COUNCIL

“Commencing at the point named NP along the Indian Ocean Coast in the South Westerly direction along the bearing of 16° for 3.4 km to point VL845, thence Southerly East along the bearing of 12° for 4.1km to point VL831 along Kitumbikwela – Shuka boundary. Thence Southerly East in the direction bearing of 03° for 6.3km along Mnali-Navanga boundary to point VL810. Thence North Westerly from there along the bearing of 69° for 4.5km crossing Mnali-Nampunga road to point VL832. Thence Southerly West at the distance of 4.0km and along the bearing of 84° crossing Simana- Kitumbikwela road to point SL664. Thence South Westerly along the bearing of 78° for 3.4km along Simana- Kitumbikwela boundary to point VL598 that is along Lindi Bay and crossing the bay to the point where Lukuledi river enters the Lindi Bay. Thence following the Lukuledi river to point VL775. Thence North Westerly along the bearing of 26° for 1.5km along Mkwaya-Mahumbika boundary to point VL757. Thence North Westerly along the bearing of 51° to point VL756 from where it crosses Mingoyo-Masasi road along the bearing of 56° for 2.1 km to point VL793. Thence turning at bearing of 51° for 4.7km along Mahumbika-Mnazimmoja boundary South Westerly to point VXL1. Thence North Westerly along the bearing of 63° for 3.7km along Ruaha-Kiwalala boundary to point VL849. Thence North Westerly along the bearing of 30° for 5.3km to point VL850. Thence north Westerly along the bearing of 71° for 10.4km to Rutamba ya Zamani- Chiponda boundary to point VL784. Thence North Westerly along the bearing 770 for 3.2km to Rutamba ya Sasa-Chiponda boundary to point VL837. Thence South Westerly along the bearing 67° for 10.5 to Luchemi-Chiponda boundary to point VL919, thence South Westerly direction along bearing of 85° for 2.5km to point VL894, and North Westerly along the bearing of 84° for 1.7km to point VL855A respectively along Luchemi-Mtakuja boundary. Thence North Westerly along the bearing of 42° for 3.3km to point VL889. Thence North Westerly along the bearing of 64° for 12.7km along Namtamba-Ntene boundary to point VL816. Thence North East along the bearing of 39° for 8.1km along Namtamba-Ntene boundary to point VL618. Thence North Easterly direction along the bearing of 2° for 6.8km Mputwa-Mandawa boundary to point VL581. Thence North Westerly along the bearing of 34° for 9.8km Kiwawa-Mandawa boundary to point VL517. Thence North Westerly direction along the bearing of 3° for 12.8 to point VL596. Thence along the Mbwemkuru river Mpingo-Mbwemkuru boundary North Easterly direction to point VL998, and Mnyangara-

Mbwemkuru boundary, Mkwajuni-Mbwemkuru boundary respectively. Thence Easterly direction to Mvuleni and Kijiweni at where Mbwemkuru river enters the Indian Ocean to point NP Mvuleni 'B'-Kijiweni boundary. Thence South Easterly bordering with the Indian Ocean to point VL951, VL922, VL923A, VL933, VL918 and VL908 respectively. Thence it crosses the Lindi Bay to point NP (Kitumbikwela) along Indian Ocean at where the boundary commenced.
