| Citation | 1. This Order may be cited as the Public Finance (Remittance of Revenue to the Consolidated Fund)(Public Corporations, Government Agencies and Authorities) Order, 2018 and shall be deemed to have come into operation on the first day of October, 2018. |
| Remittance | 2. The Public Corporations, Government Agencies and Authorities specified in the Schedule to this Order shall remit fifteen percent (15%) of its annual gross revenue to the Consolidated Fund annually. |
| Period of Remittance | 3. The amount specified in paragraph 2 shall be remitted quarterly to the Consolidated Fund in an equal amount of three point seven five (3.75%) of the gross revenue. |
